Add: Subsection 4 - TIPPING AND USER FEES:

- a. The Cortland County Department of Solid Waste shall collect a fee for the disposal of solid waste at landfill sites operated in and for the County of Cortland.
- b. The Fees, rates or charges for the disposal of solid waste at County owned and operated landfills shall be established by resolution of the Cortland County Legislature and such charges shall commence upon adoption of such resolution and continue until modified, amended or rescinded.
- The Department of Solid Waste may charge for solid waste disposal on a contractual basis, subject to the approval of the Cortland County Legislature, with municipalities of Cortland County for the disposal of solid waste delivered to the County landfill by vehicles owned and operated by such municipality in the collection of solid waste.
- d. Except as otherwise provided herein or by resolution duly adopted by the Cortland County Legislature, there shall be no other charge for use of the landfill sites operated in and for the County of Cortland.

- e. The Department of Solid Waste with approval of the Solid Waste Committee shall establish rules and procedures for the collection of said user fees.
- f. All charges and fees collected by the Department of Solid Waste pursuant to this provision shall be deposited with the Cortland County Treasurer and first applied to pay the operating expenses of any County owned and operated landfill and to the expenses of said Department of Solid Waste.
- Section 2. Except as hereinabove amended, modified and changed said Local Law No. 3 of 1981 as amended by Local Law No. 2 of 1983, shall remain in full force and effect.
- Section 3. This Local Law shall take effect following a public hearing held before the County Legislature in the manner provided by law.
