

RESOLUTION NO. 97-19

Local Law 2 of 2019- a Local Law Amending Local Law 5 of the Year 2014, Providing for a Real Property Tax Exemption for Cold War Veterans Pursuant to Real Property Tax Law Section 458-B

Be it enacted by the Legislature of Cortland County as follows:

Section 1:

That Section 5(c) of Local Law No. 5 of the year 2014 is amended by adding a subparagraph as follows:

- A. Pursuant to subsection 2(c)(iii) of §458-b of the NYS Real Property Tax Law, the exemption authorized shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to such ten year limitation.

Section 2:

This Local Law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all assessment rolls prepared pursuant to the first taxable status date occurring on or after the effective date of this local law.
